Notice is hereby given of a public non-judicial foreclosure sale.

1. <u>Property To Be Sold</u>. The property to be sold is described as follows:

All that certain lot, tract or parcel of land being Lot Thirty-Three (33), EUREKA FOREST SUBDIVISION, according to the plat recorded in Volume 7, Page 6, Plat Records of Navarro County, Texas.

2. <u>Date, Time, and Place of Sale</u>. The sale is scheduled to be held at the following date, time, and place:

Time: The sale shall begin no earlier than 10:00 a.m. or no later than three hours thereafter.

The sale shall be completed by no later than 1:00 P.M.

The deed of trust permits the beneficiary to postpone, withdraw, or reschedule the sale for another day. 3. <u>Terms of Sale</u>. The sale will be conducted as a public auction to the highest bidder for cash, subject to the provisions of the deed of trust permitting the beneficiary thereunder to have the bid credited to the note up to the amount of the unpaid debt secured by the deed of trust at the time of sale.

Those desiring to purchase the property will need to demonstrate their ability to pay cash on the day the property is sold.

The sale will be made expressly subject to any title matters set forth in the deed of trust, but prospective bidders are reminded that by law the sale will necessarily be made subject to all prior matters of record affecting the property, if any, to the extent that they remain in force and effect and have not been subordinated to the deed of trust. 5. <u>Obligations Secured</u>. The deed of trust provides that it secures the payment of the indebtedness and obligations therein described (collectively the "Obligations") including but not limited to (1) the promissory note in the original principal amount of \$54,900.00, executed by Harold and Julie Rose, and payable to the order of Don Ballew, P. O. Box 176, Frost, Texas 76641; and (2) all modifications, renewals and extensions of the note. Don Ballew is the current owner and holder of the Obligations and is the beneficiary under the deed of trust.
