Citizens appearing during this time will be allowed to present their concern and are limited to a three-minute time period; however, the Board of Directors are prohibited from entering into deliberations, and then the item may be referred to a future agenda for discussion.

6. Discuss and consider payment of bills for the Levee District, including the following:

9. Discuss and consider setting proposed ad valorem tax rate for the year 2022.
10. Discuss and consider setting the date for a public hearing to determine the ad valorem tax rate for the Levee District for the year 2022
11. Discuss and consider Infrastructure Responsibilities to Protect Life and Property of Natural Resources Conservation Service.

12. Discuss and consider the condition of the Levee District property and any possible repairs that may be necessary.
13. Discuss and consider approval of collection agreements with each of the county tax assessor collectors and/or appraisal districts in which the Levee District operates.

If during the course of the meeting covered by this notice, the Levee District should determine that a closed or executive meeting or session of the Levee District or a consultation with the attorney for the Levee District should be held or is required, then such closed or executive meeting or session or consultation with attorney as authorized by the Texas Open Meetings Act, Texas Government Code 551.001 et. seq., will be held by the Levee District at the date, hour and place given in this notice as the Levee District may conveniently meet in such closed or executive meeting or session or consult with the attorney for the Levee District concerning any and all subjects and for any and all purposes permitted by the Act, including, but not limited to, the following sanctions and purposes:
