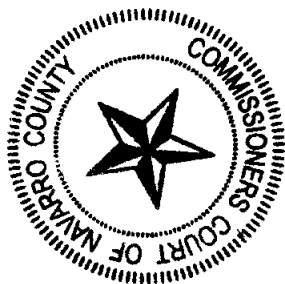

**DISASTER DECLARATION
Threat of Wildfires**

Whereas, Navarro County is experiencing adverse conditions from wildfires due to heavy fuel loads and dry/windy conditions; and

Whereas, weather forecasters offer little promise of a change in these dry/windy conditions in the near future; and

Whereas, these dry/windy conditions pose a threat of fast-moving wildfires; and

Whereas, such fires have the potential of endangering lives and damaging property on a wide scale; and

Whereas, the Texas Disaster Act of 1975 authorizes the declaration of a state of disaster "if the threat of disaster is imminent"; and

Whereas, the magnitude of the potential damage and the rapidity at which such a fire could escalate to major proportions constitutes an imminent threat of disaster; and

Whereas, declaration of such a disaster authorizes the imposition of controls on activities which tend to increase the likelihood of such fires; and


Whereas, such controls, once implemented, have the potential of protecting lives and property by mitigating the threat of dangerous fires;

BE IT THEREFORE PROCLAIMED that I, H. M. Davenport, County Judge, do hereby declare a state of disaster based on the threat of wildfires in Navarro County.

BE IT ALSO PROCLAIMED that this state of disaster will continue until rescinded in accordance with the above-cited statute, **but in no instance will this declaration continue for more than seven days without authorization by the Navarro County Commissioners Court;**

BE IT ALSO PROCLAIMED that this state of disaster is being declared solely for the purpose of implementing controls aimed at mitigating the hazard posed by wildfires during dry/windy weather.

EMERGENCY ORDER

PROHIBITION OF OUTDOOR BURNING

Whereas, in accordance with the provisions of the Texas Disaster Act of 1975;
and

Whereas, it is now necessary, under the above referenced authority, to declare a state of disaster for Navarro County due to the imminent threat of disaster from wildfires;
and

Whereas, the declaration of such a disaster authorizes the imposition of controls on activities which tend to increase the likelihood of such fires; and

BE IT THEREFORE ORDERED that the following emergency regulations are hereby established for all unincorporated areas of Navarro County, Texas for the duration of the above-mentioned declaration:

(1) Actions prohibited:

A person violates this order if he burns any combustible material outside of an enclosure which serves to contain all flames and/or sparks, or orders such burning by others.

(2) Enforcement:

(a) Upon notification of suspected outdoor burning, the fire department shall respond to the scene and take immediate measures to contain and/or extinguish the fire.

(b) As soon as possible a duly commissioned peace officer shall be sent to the scene to investigate the nature of the fire.


(c) If, in the opinion of the officer and/or fire chief, the goal of this order can be attained by informing the responsible party about the prohibitions established by this order; the officer/fire chief may, at his discretion, notify the party about the provisions of this order and request compliance with it. In such instances, a record of this notification shall be made in the dispatcher's log containing date, time and place of the violation. At the discretion of the officer/fire chief, violations of this order may be prosecuted in accordance with the statutes and procedures governing misdemeanors. In accordance with the local government code, a person who knowingly or intentionally violates this Order commits a Class C Misdemeanor, punishable by a fine of up to \$500.00.


BE IT ALSO ORDERED that this order may be enforced by any duly commissioned peace officer and that venue for prosecution of violations of this order will be in the Justice of the Peace Courts of Navarro County, Texas.

BE IT FURTHER ORDERED that the purpose of this order is the mitigation of the hazard posed by wild fires during the current dry/windy weather by curtailing the practice of outdoor burning, which purpose is to be taken into account in any enforcement action based upon this order.

WHEREAS, the magnitude of the potential danger and rapidity at which a fire could escalate to major proportions constitutes an imminent threat of disaster; and

WHEREAS, declaration of such a disaster authorizes the imposition of controls on activities which tend to increase the likelihood of such fires; and

WHEREAS, such controls, once implemented have the potential of protecting lives and property by mitigating the threat of dangerous fires; and


WHEREAS, H.M Davenport, County Judge, on the 2nd day of January, 2008, declared a state of disaster based on the threat of wildfires in Navarro County; and


WHEREAS, that this state of disaster will end seven days following its issuance without authorization of Navarro County Commissioners Court; and


BE IT THEREFORE RESOLVED that this state of disaster continuance is in effect until it is rescinded by action of the Commissioners Court; and

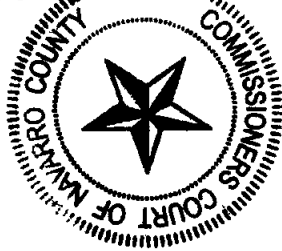





I, Frank Hull, the Navarro County Treasurer, on this 25 th day of April, 2011 present to the Navarro County Commissioners Court the Monthly Financial Report for the month ending on March 31, 2011 for the court to review and approve. According to the report, Navarro County had cash on hand in the amount of \$ 7,187,058.40. Bank collateral for deposits held at Depository Bank was \$ 24,342,618.11. Collateralization is 344% of deposits. Also, other assets totaling \$ 6,165,659.18 are being held by the Treasurer's office. The total interest for all accounts for the month of March, 2011 was \$ 8,555.52. The total disbursements for the month of March, 2011 were \$ 2,814,666.01. This report is in compliance with section 114.026 of the Local Government Code, so therefore we hereby execute this affidavit for publication.



INTERLOCAL CONTRACT FOR TAX COLLECTION

This contract is entered into between NAVARRO COUNTY, hereinafter called "County", and CORSICANA ISD, hereinafter called the "School", pursuant to the provisions of Article 4413 (32c) of the Texas Revised Civil Statutes and Selections 6.23 (a) of the Property Tax Code of Texas.

I. Purpose

The purpose of this contract is to provide for the assessment and collection of ad valorem taxes on behalf of the School by the County. County agrees to assess and collect ad valorem taxes on behalf of School during the contract term, and School agrees to cooperate with County in the performance of such assessment and collections.

II. Term

This contract is to take effect and shall be for the period of July 1, 2011, through June 30, 2012. On July 1st of each succeeding year, this contract will automatically renew. If either party wishes to cancel the automatic renewal provision of this contract, such party must give the other written notice by certified mail at least 60 days prior to the automatic renewal date of July 1st. It will be deemed that the parties' silence is affirmative acceptance of the one-year renewal and extension.

III. Limitations Designated by School

The School is governed by the statutes, constitution, and laws of the State of Texas.

IV. Qualified Staff

County agrees to employ qualified tax collectors and assessors as may be required from time to time by the laws of this state to assist in the performance of the obligations of County under this agreement.

V. Delinquent Tax Attorney

School will allow for the collection of delinquent taxes. County shall be responsible for supervising the efforts of any delinquent tax attorney selected by County. However, if School has a current contract with a delinquent tax attorney, that contract will be honored by County.

VI. Bonds and Deposits

The County agrees to maintain Public Employee Dishonesty Bond Insurance in the amount of \$50,000 per employee. The County will deposit funds as collected on a daily basis in insured accounts with local banking institutions and will disperse collected funds to the School weekly, provided however, there are no extenuating circumstances of which the County has no control.

VII. General Requirements

County agrees to:

- A. Deliver all notices required under the Property Tax Code of the State of Texas on a timely basis on behalf of the School.
- B. Complete all reports required by the School under the Property Tax Code of the State of Texas and submit those reports to the appropriate officials on a timely basis.
- C. Insure compliance with present and future property tax calendars.
- D. Keep accurate records of all School tax collections and to make such records available for inspection during normal working hours by any authorized representative of the School, and
- E. Keep a current delinquent tax roll and to reconcile the delinquent tax roll annually.

VIII. Tax Certificates

County shall prepare and issue tax certificates to taxpayers on behalf of the School and shall be entitled to collect any statutory fees therefore. Any fees collected will be the property of the County.

IX. Tax Assessor/Collector

The County shall be the agent for the purpose of assessing and collecting taxes of the School. In regards to the assessment and collection of taxes, County agrees to accept any reasonable direction, supervision, and requirements of the School not inconsistent with the laws of this state of County's normal operating procedures. In the performance of this agreement, County shall be deemed to be recommending actions to the School, and may take such actions as it believes appropriate and recommends from time to time unless objection is made by the School.

X. Compensation

In exchange for its services to be rendered under this agreement, School agrees to pay County Forty-one cents per parcel (\$0.41/parcel) based on previous year's parcel amounts for the School as reported by the Navarro Central Appraisal District.

XI. Computerized Records

County agrees to maintain all records regarding the assessment and collection of taxes on behalf of the School with periodic back up of data via hard copy or disc safely stored in accordance with the County and School regulations and State law. County further agrees to provide at any reasonable time upon written request from the School, a printout reflecting the current status of the assessment and collection of taxes, within one (1) business day after such request.

XII. Applicable Laws


This contract shall be governed by Article 4413 (32) of the Texas Revised Civil Statutes, and Sections 6.23 (a), 6.27 (b), and 6.30, as well as the other provisions of the Property Tax Code of Texas, and any other laws, rules, or statutes now existing or which may hereafter be enacted covering any part of the subject matter of this agreement. In the event of any conflict between the terms and provisions of this agreement and any such statutory requirements, or the common law of Texas, or any provision of the Constitution of the State of Texas, the parties request any court considering same to construe this agreement in such a way as to be in compliance therewith, and in this respect hereby agree that any such inconsistent term or provision of this agreement, or any term or provision not included hereby but required by any such statute, constitutional provision, or other rule of law, shall be supplied by such court as nearly as possible so as to comply therewith and to effectuate the intent of the parties as expressed herein. In the event of any contention that the charges made hereunder exceed those allowed by Section 6.27 (b) of the Property Tax Code, a fair and reasonable portion of general overhead and operating expense of County shall be allocated in determining such matters.

Each party executing this agreement represents to the other that his or her execution hereof is properly authorized by the required vote of the governing body of the respective party. This agreement is executed effective the 25th day of April, 2011.


