

Item #3 on the agenda was consideration of a replat of lot #1 in Grandview Ranchettes to incorporate 0.72 acre owned by Grandview Estates Property Owners Association for Bill & Ellen Schwab, motion to approve by Commissioner Irvine, second by Commissioner Bancroft, all voted aye with exception to Commissioner Moe who abstained from voting.

Item #4 on the agenda was consideration of a specific use permit with a variance for a 24'x30' storage building on lot #8 of SouthPoint subdivision for Robert Gray, motion to approve by Commissioner Moe, second by Commissioner Newton, all voted aye.

Item #5 on the agenda was consideration of a specific use permit to live in an RV on site while home is being built on lot #33 of Chandler's Landing subdivision for Paul & Charlotte Rasbury. Item was approved contingent upon the contractor (Harold Prater) obtaining a building permit within thirty (30) days and the issuance of a specific use permit coinciding with the building permit and being issued for six (6) months, motion to approve by Commissioner Irvine, second by Commissioner Moe, all voted aye.

Item #6 on the agenda was a Public Hearing on amending oil drilling regulations in the Richland –Chambers Lakeshore Area. The Board heard from Joe Stone and Robert Smith representing

PacePetro and Josh Broach representing Texas Land and Lakes. The Board decided to form an ad hoc committee composed of oil and gas developers and real estate developers in order to see if an amendment should be made and the details thereof. The members of the committee are to be determined. The public hearing was then closed.

DECLARING A LOCAL STATE OF DISASTER


WHEREAS, the County of Navarero on the 4th day of September, 2011 has suffered widespread or severe damage, injury, or loss of life or property (or there is imminent threat of same) resulting from numerous wildfires and;

WHEREAS, the judge of the County of Navarero has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property;

NOW, THEREFORE, BE IT PROCLAIMED BY THE JUDGE OF THE COUNTY OF NAVARRO:

1. That a state of disaster is declared for the County of Navarero.
2. That the County's Emergency Management Plan has been implemented.
3. That this state of disaster shall continue for a period of not more than seven days of the date hereof, unless the same is continued by consent of the Commissioners Court of the County of Navarero, Texas.
4. That this proclamation shall take effect immediately from and after its issuance.

As a result of wildfires that occurred on September 4th, 2011, Navarro County is currently facing tremendous physical and economic losses. 4 businesses have sustained significant uninsured losses. These business losses have created a severe impact on jobs, production, and revenue.

It is my belief the damage to businesses due to the wildfires constitutes a severe economic loss. I have determined that this incident is of such severity and magnitude that an effective response is beyond Navarro County's capability to recover without supplementary State and/or Federal assistance. Additionally, I certify that Navarro County does not have local funding available to make the needed repairs and to provide these citizens with effective relief.

Your assistance in this emergency matter, as it affects the safety and health needs of our citizens would be greatly appreciated.






