Let it be resolved, the Navarro County Commissioner's Courts accepts as part of the Early Retiree Reinsurance Program (ERRP) a disbursement provided by TAC Health and Employee Benefits Pool (HEBP) acting on behalf of Pool members a check for \$ 27,645.22. The Commissioner's Court hereby authorizes H.M. Davenport as County Judge the authority to sign the "ERRP Acknowledgement Form" as an agreement to use the money per statue when received.

Pursuant to the ERRP regulations,

A sponsor must use the proceeds under this program (1) To reduce the sponsor's health benefit premiums or health benefit costs, (2) To reduce plan participants' health benefit premium contributions, copayments, deductibles, coinsurance, or other out-of-pocket costs, or any combination of these costs, or (3) To reduce any combination of the costs specified in(1) and (2). Proceeds received pursuant to this program may not be used as general revenue of the sponsors. Thus, to the extent a sponsor decides to use the reimbursement for its own purposes, it may use the reimbursement only to offset increases in the sponsor's health benefit premiums or health benefit costs.
