1. Restore existing clock faces (4 each) per the following process:

- Removal of all garbage/dead birds/bird feces from existing clock tower (workers to wear full suits/respirators)
- Historic documentation of all components including numbering/labeling and photographs.
- Remove broken glass from backside of 3 clock face frames. Pieces of glass not already broken shall be cleaned and glazing putty repaired.
- Prep/paint per manufacturer's instruction with Sherwin Williams DTM (1 color – black).
- Broken pieces to be replaced with similar color glass.
- Final clean of all glass and clock components.


