2. A 6" floor on poly reinforced w/ #4 bars @ 18" O.C.E.W.
3. A 12" x 24" perimeter beam and 3 cross-beams reinforced with (4) #5 bars continuous.
4. This contractor will set the anchor bolts provided by the metal building supplier.
5. Sawn control joints to help control shrinkage crack caused when the concrete cures.
