

DECLARATION OF LOCAL DISASTER EXTENSION


**WHEREAS**, Navarro County on the 23<sup>rd</sup>, 24<sup>th</sup> of October, 2015, has suffered widespread damage, injury, or loss of life or property (or there is imminent threat of same) resulting from extremely heavy rainfall throughout Navarro County over that 36 hour period, and then AGAIN on October 30 and 31, all causing extreme flash flooding throughout the county, and

**WHEREAS**, the County Judge and Commissioner Court of Navarro County has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property,


**NOW, THEREFORE, BE IT PROCLAIMED BY THE COUNTY JUDGE and COMMISSIONERS COURT OF NAVARRO COUNTY:**


1. That the local state of disaster declared for Navarro County on October 24<sup>th</sup> by County Judge H.M. Davenport, Jr., is hereby extended for 30 days from that date pursuant to §418.108(a) of the Texas Government Code, including all incorporated cities and jurisdictions within Navarro County, and, at this point, the recent rain/flood events, as dated above, and more forecasted at this time, that continue the flooding and damages given the extremely wet current conditions.
2. Pursuant to §418.018(c) of the Government Code, this extension of said declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the County Clerk.
3. Pursuant to §418.018(d) of the Government Code, this declaration of a local state of disaster activates the Navarro County emergency operations plan.
4. That this proclamation shall take effect immediately from and after its issuance.
