Dear Governor Abbott:

DECLARATION OF LOCAL DISASTER

WHEREAS, Navarro County on the 26<sup>th</sup> and 27<sup>th</sup> day of December, 2015, has suffered widespread damage, injury, or loss of life or property (or there is imminent threat of same) resulting from extremely heavy rainfall throughout Navarro County over that two day time period causing extreme flash flooding throughout the county, and

WHEREAS, the County Judge of Navarro County has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property,

NOW, THEREFORE, BE IT PROCLAIMED BY THE COUNTY JUDGE OF NAVARRO COUNTY:

1. That a local state of disaster is hereby declared for Navarro County pursuant to §418.108(a) of the Texas Government Code, including all incorporated cities and jurisdictions within Navarro County.
2. Pursuant to §418.018(b) of the Government Code, the state of disaster shall continue for a period of not more than seven days from the date of this declaration unless continued or renewed by the Commissioners Court of Navarro County.
3. Pursuant to §418.018(c) of the Government Code, this declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the County Clerk.
4. Pursuant to §418.018(d) of the Government Code, this declaration of a local state of disaster activates the Navarro County emergency operations plan.
5. That this proclamation shall take effect immediately from and after its issuance.
