Davenport Jr.</u>, County Judge \_\_\_\_\_, Commissioner, Precinct 1 \_\_\_, Commissioner, Precinct 2 Eddie Moore , Commissioner, Precinct 3 Dames Olsen Commissioner, Precinct 4 and the following members absent, to-wit: Eddie Perry, Jason Grant. , constituting a quorum, when among other business, the following was transacted: ORDER AUTHORIZING EARLY ADDITIONAL PENALTY ON DELINQUENT PERSONAL PROPERTY TAXES UNDER TEX. TAX CODE § 33.11 IN ORDER TO DEFRAY COSTS OF COLLECTION. Commissioner Eddie Moore introduced an order and made a motion that the same be adopted. Commissioner JAMES OLSEN seconded the motion for adoption of the order. The motion, carrying with it the adoption of the order, prevailed by the following vote: AYES: NAYS:

The County Judge thereupon announced that the motion had duly and lawfully carried and that the order had been duly and lawfully adopted. The order thus adopted follows:

ABSTENTIONS:

WHEREAS, Navarro County wishes to defray its costs of collection, as authorized by TEX. TAX CODE § 33.11, that it incurs under a contract for collection of delinquent property taxes between said county and a private law firm entered into pursuant to TEX. TAX CODE § 6.30;

WHEREAS, under said Section 33.11, Commissioners Court is empowered to authorize the addition of a collection penalty in an amount

that does not exceed the amount of the compensation specified in the contract with the private law firm;

NOW, THEREFORE,

BE IT ORDERED BY THE COMMISSIONERS COURT OF NAVARRO COUNTY, TEXAS, SITTING AS THE GOVERNING BODY OF SAID COUNTY, THAT:

<u>Section 1:</u> THE RECITALS SET FORTH IN THIS ORDER ARE TRUE AND CORRECT.

Section 2: AN ADDITIONAL PENALTY ON DELINQUENT PERSONAL PROPERTY TAXES FOR TAX YEAR 2020 AND SUBSEQUENT YEARS IS HEREBY AUTHORIZED AND IMPOSED, AS PROVIDED BY SECTION 33.11, TEXAS TAX CODE, IN THE AMOUNT OF 20% OF THE DELINQUENT TAX, PENALTY AND INTEREST IF THE TAX BECOMES DELINQUENT ON FEBRUARY 1 OF A YEAR AND REMAINS DELINQUENT ON THE  $60^{TH}$  DAY THEREAFTER.
