**A RESOLUTION OF THE COMMISSIONER'S COURT OF NAVARRO COUNTY ,
CORSICANA, TEXAS, APPROVING THE TERMS AND CONDITIONS OF AN
ADVANCE FUNDING AGREEMENT AND AUTHORIZING THE NAVARRO
COUNTY JUDGE TO ENTER AND SIGN THE AGREEMENT BETWEEN NAVARRO
COUNTY AND THE TEXAS DEPARTMENT OF TRANSPORTATION FOR AN OFF
THE STATE SYSTEM BRIDGE REPLACEMENT OF THE SW CR 2305 AT PIN OAK
CREEK BRIDGE**

WHEREAS, Title 23 United States Code Section 144 authorizes federal funds to assist the states in the replacement or rehabilitation of deficient bridges located on public highways, roads, and streets, including those under the jurisdiction of local governments; and

WHEREAS, the County of Navarro (Local Government) owns the bridge on a public road located at SW CR 2305 at Pin Oak Creek, and the bridge is included in the approved off-state system federal-aid Highway Bridge Replacement and Rehabilitation Program (HBRRP) as authorized by Texas Transportation Commission Minute Order Number 115814, dated August 27, 2020, Control Section Job (CSJ) Number 0918-18-137, National Bridge Inventory Structure # 18-175-0-AA05-52-001; and

WHEREAS, the Highway Bridge Replacement and Rehabilitation Program provides for the funding of authorized bridge work at ninety nine and one half percent (99.5%) with a required Navarro County funding match one half percent (0.5%) of preliminary engineering, construction engineering, and construction cost for the replacement of the SW CR 2305 Pin Oak Creek bridge; and

WHEREAS, the Navarro County Commissioner's Court has approved and entering into the agreement for this Project by this resolution; and

**NOW, THEREFORE BE IT RESOLVED BY THE NAVARRO COUNTY
COMMISSIONER'S COURT OF NAVARRO COUNTY, TEXAS:**

Section 1. That the Agreement having been reviewed by the Commissioner's Court of Navarro County, Texas and found to be acceptable and in the best interest of the County and its citizens.

Section 2. That the County Judge is hereby authorized to enter into and sign an advance funding agreement with the State of Texas, acting through the Texas Department of Transportation for the bridge replacement of the SW CR 2305 Pin Oak Creek bridge

Section 3. This Resolution shall become effective immediately upon passage.
