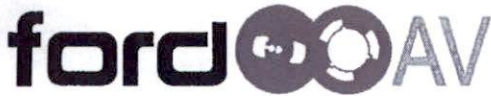

Ford shall provide and install the following systems for Texoma HIDTA of Irving, Texas in their office relocation:

1. CONFERENCE ROOM

a. VIDEO SYSTEM

- 1) One (1) 75" 4K, commercial grade, flat panel display with articulating-arm mount shall be provided and installed on the west wall to show Customer provided content.
 - a) The Customer is responsible for providing electrical power and blocking, if needed, to the display location.
 - b) The Customer is responsible for providing a live network connection to the display location.
- 2) One (1) video bar integrated with a wide angle 4K camera, 27-microphone array, and two (2) smart speakers shall be wall mounted below the display.
- 3) One (1) HDMI connection and one (1) USB Type-A connection shall be provided at the OFE conference table to allow a laptop to connect with the room's display, and video bar with owner furnished HDMI and USB cables.
- 4) One (1) HDMI transmitter shall be provided and installed under the OFE conference table and one (1) HDMI receiver shall be provided and installed behind the display.
- 5) One (1) USB 3.0 Extender transmitter shall be provided and installed under the OFE conference table and one (1) USB 3.0 Extender receiver shall be provided and installed behind the display.
- 6) The Customer is responsible for providing all necessary items to perform web-conferencing, including but not limited to, providing/maintaining network infrastructure, network security, user accounts and credentials, antivirus software, web-conferencing provider subscriptions and software, and system configurations unless stated otherwise securely and reliably in this Description of Work.

2. EXECUTIVE CONFERENCE ROOM

a. AUDIO SYSTEM

- 1) One (1) digital signal processor (DSP) with echo cancellation capability shall be mounted behind the display.

- 2) One (1) beamforming microphone array with an integrated amplifier shall be provided and installed in the ceiling above the OFE conference table to capture the near-side audience during web and audio conferencing.
- 3) Two (2) 6" 2-way flush mounted ceiling speakers shall be provided and installed above the OFE conference table and receive signal from the integrated microphone amplifier.

b. VIDEO SYSTEM

- 1) Two (2) 86", UHD resolution, commercial grade, flat panel displays and articulating-arm mounts shall be supplied, and wall mounted, one on the north wall and one on the west wall of the room.
 - a. The display on the west wall shall be the primary display for video conferencing.
- 2) One (1) 1080P, 12x digital zoom, PTZ camera shall be provided and installed on the west wall below the display to capture the near-side audience during web conferencing.
 - a. The camera shall be controlled with the manufacturer provided handheld remote control.
- 3) One (1) HDMI connection and one (1) USB connection shall be provided at the OFE conference table to allow a laptop to connect with the room's displays, camera, microphone and speakers.
- 4) One (1) HDMI distribution amplifier shall be provided and installed behind the west wall display for the routing of signals to each display.

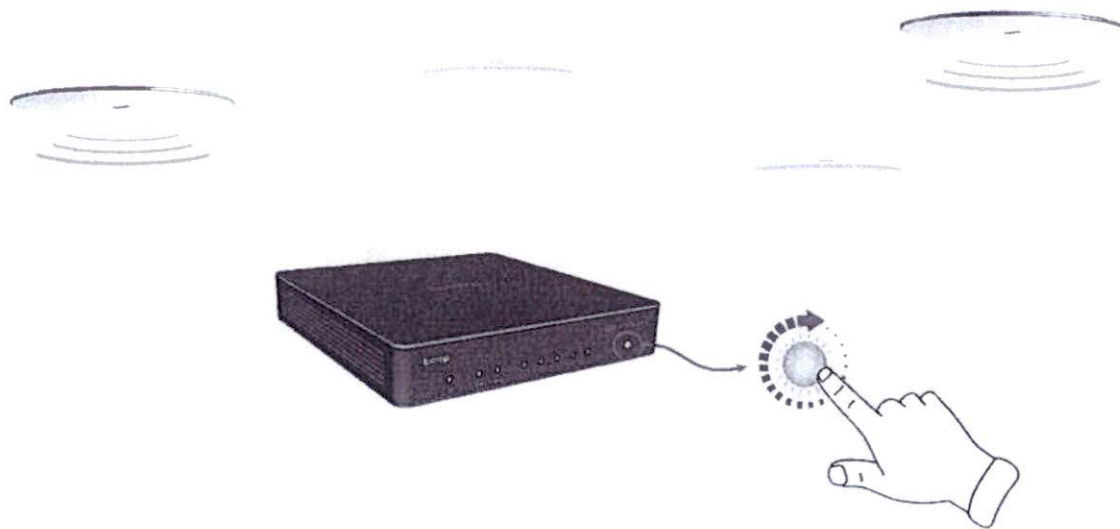

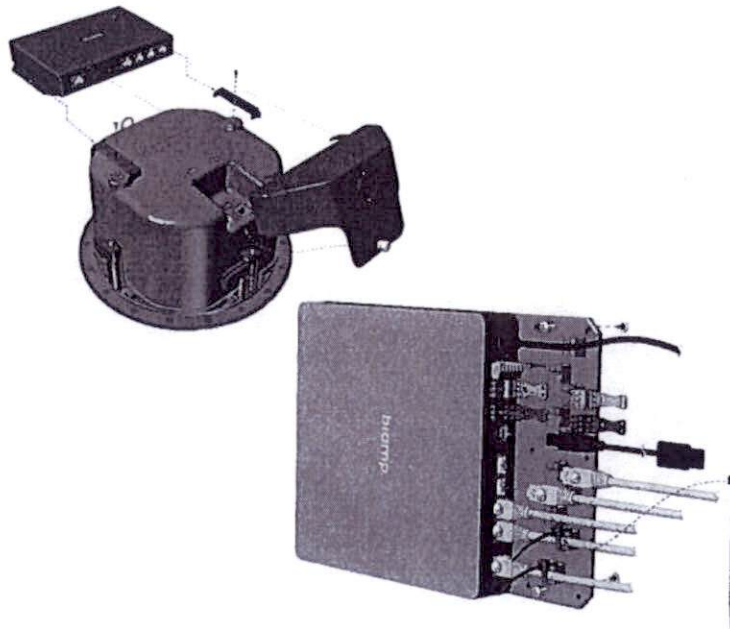
