## Road Permit Bond

KNOW ALL MEN BY THESE PRESENTS, That We <u>Tehuacana Creek Solar LLC</u> hereinafter referred to as the Principal, and <u>Accelerant National Insurance Company</u>, a corporation organized and existing under the laws of the State of <u>Delaware</u> and authorized to do business in the State of <u>Texas</u> as Surety, are held and firmly bound unto <u>Navarro County Commissioners Court</u>, herein after referred to as Obligee, in the sum of <u>Eight Hundred Thousand and 00/100 Dollars (\$800,000.00)</u> lawful money of the United States of America, to the payment of which sum, well and truly to be made, we bind ourselves, our executors, administrators, successors and assigns, firmly by these presents. The surety shall not be liable for a larger amount, in the aggregate, than the amount of this bond.

THE CONDITION OF THIS OBLIGATION IS SUCH, That whereas, the Principal has made application for a Permit of Road Use of SW CR 2370 (1.09 miles), SW CR 2380 (2.95 miles), SW CR 2360 (1.38 miles), SW CR 2386 (1.26 miles), FM 246 (1.1 miles).

NOW, THEREFORE, if said Principal shall faithfully perform all the duties of Road Use Permit according to the requirements of the ordinance of said Navarro County

Commissioners Court and protect said SW CR 2370 (1.09 miles), SW CR 2380 (2.95 miles), SW CR 2360 (1.38 miles), SW CR 2386 (1.26 miles), FM 246 (1.1 miles) from any damage as hereinbefore stated, then this obligation shall be null and void; otherwise to remain in full force and effect.

THIS BOND WILL EXPIRE <u>September 15, 2026</u>, but may be continued by continuation certificate signed by Principal and Surety. The surety may at any time terminate its liability by giving thirty (30) days written notice to the Obligee, and the surety shall not be liable for any default after such thirty-day notice period, except for defaults occurring prior thereto.
