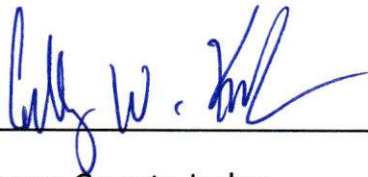
Applications for ballot by mail and federal post card applications (FPCA) must be received no later than the close of business on Friday October 23rd, 2026
